General program - Our mission continues to be to promote wellness and enrich lives in underserved communities through the power of healthy foods and human connection. In 2018 FEAST served over 1500 individuals in Los Angeles County, and also trained over 50 FEAST Affiliate partners to provide our programs in communities nationwide. Our core 16-week wellness programs provided over 200 families in South Los Angeles with practical tools like nutrition education, basic healthy cooking, and shopping skills, as well as access to healthy foods in an environment of peer-to-peer support. Additional community programs reached 400 families, providing cooking classes, food access, movement challenges, and graduate support services.

The President shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement. c. After exercising due diligence, the Board shall determine whether the Corporation can obtain with reasonable efforts a more advantageous transaction or arrangement from a person or entity that would not give rise to a conflict of interest. d. If a more advantageous transaction or arrangement is not reasonably possible under circumstances not producing a conflict of interest, the Board shall determine by a majority vote of the disinterested Directors whether the transaction or arrangement is in the Corporation's best interest, for its own benefit, and whether it is fair and reasonable. It shall make its decision as to whether to enter into the transaction or arrangement in conformity with this determination.
